## **ORDER**

Heard Sri Amit Anand Deshpande, learned counsel for the review petitioner. Finding sufficient reason the order dated 26.07.2023 is recalled. I.A.3/2023 is allowed.

2. We have heard learned counsel on admission of the review petitions. All the grounds that learned counsel has taken in the review petitions are in the nature of grounds that can be urged in the appeal. It is a well established principle that the grounds that can be taken in the appeal cannot be considered for granting review. But at this stage Sri Amit Anand Deshpande submits that the

observation made in para 11 of the order was not the submission actually made by him while he argued on the merits of writ petitions. What we have observed is, "It was not the argument of Sri. Amit Deshpande that there was no application of mind by the competent authority". If really Sri Amit Deshpande did dot argue in this way we may expunge this sentence. However, in spite of expunction, we do not find any ground to admit the review petitions.

- 3. Sri Amit Deshpande has submitted that initiation of four enquiries against the petitioner in connection with surprise visits to four hostels on 31.01.2018 is bad in law, and he submits that one enquiry was enough.
- 4. We find force in his submission. Though surprise visits to four hostels are different, all the four visits were on the same day in the same town or city. One enquiry in respect all the four suffices the situation. The petitioner is given liberty to raise this issue before the enquiring

authority, and if it is raised, the enquiring authority shall consider it.

Review petitions are not admitted, they are dismissed.
