This CCC is filed U/Sec.11 & 12 of the Contempt of Court Act, praying to pass orders U/Sec.11 and 12 of Contempt of Courts, take initiative of Civil Contempt of Courts Act 1971 for having willful disobeying of order dated : 30-04-2015 passed in W.P.No.202843/2015 of this Hon'ble Court.

This CCC coming on for Orders this day, **H.Billappa J.**, made the following:

ORDER

The learned Government Advocate has filed a memo along with copy of the letter dated 30-07-2015 and the same is taken on record.

2. It is stated in the memo that the accused has sent the service register of Mohd. Alam to the Principal

Bhangurnagar PU College, Dandeli. As the service register is sent, the contempt proceedings need to be closed.

3. However, it is made clear, the Chairman of Gawan Educational Trust has produced the Service Register as per the direction of this Court. The writ petition filed by the Gawan Educational Trust is pending. It was not a party to the writ petition filed by complainant or to the contempt proceedings. In the circumstances of the case, this Court directed the Chairman, Gawan Educational Trust to produce the Service Register. Accordingly, it is produced. The Service Register is now sent to the Principal, Bhangurnagar PU College, Dandeli. In the event, the Gawan Educational Trust succeeds in the writ petition filed by it, the necessary consequences will follow.

With the above observation, the contempt proceedings are closed.

I.A.No.1/2015 does not survive for consideration and accordingly, it is rejected.
