THESE PETITIONS COMING ON FOR PRELIMINARY HEARING IN 'B' GROUP THIS DAY, THE COURT MADE THE FOLLOWING:-

ORDER

The petitioners are the purchasers of the plots in private layout and the petitioners have put up the construction. The respondents 1 and 2 issued notice of demolition of the building constructed on the civic amenity sites by the petitioners. The petitioners, therefore, seek for a writ of mandamus to the respondents 2 and 3 to permit change of land use in respect of the plots sold to the petitioners.

2. It is the contention of the petitioners that the owner of the layout has got sufficient plots and other vacant lands in the same layout and that he has given proposals vide Annexure D to respondent No. 2 to treat the said lands as civil amenity sites which is to considered by respondent No.2. It is therefore, directed

that Respondent No.2 shall consider Annexure D and pass appropriate orders in accordance with law. The writ petition is allowed.
