This Writ Petition is filed under Articles 226 and 227 of the Constitution of India, praying to issue a writ of nature of mandamus or any other writ or direction to the respondent to pay the amount as per Annexure 'C' vide SLP No.2841/12 dated 07.01.2015. Issue a writ of mandamus and direction to consider the representation filed by the petitioner at Annexure dated 22.04.2015 as per Annexure 'D'.

This petition coming on for preliminary hearing this day, the Court made the following:

#### **ORDER**

This petition is filed by the Government of India and its officers seeking the mandamus to the respondent to return Rs.75,000/-. The Division Bench of this Court, by its order dated 17.06.2011 (Annexure-A) imposed the cost of Rs.1,00,000/- on the petitioners, which cost is however reduced to Rs.25,000/- by the Hon'ble Supreme Court by its order, dated 07.01.2015 in S.L.P.No.2841/2012 (Annexure-C).

2. The respondent Bar Association has filed the memo which reads thus:

"As per the order of the Hon'ble Supreme Court of India in SLP No.2841/2012 dated 07.01.2015, the President of respondent hereby under takes to refund the amount of Rs.75,000/-to the petitioner, in 3 installments (Rs.25,000/-each installments). The 1<sup>st</sup> payment will be made within 10 days form today, the 2<sup>nd</sup> installments will be paid on 15.06.2016 and the last installment will be paid on 16.08.2016.

Hence, this memo of undertaking."

3. This petition is disposed of recording the undertaking of the respondent Association to pay Rs.75,000/- in three installments as stated in the memo.
