### **ORDER**

Taking record the affidavit of the on Superintendent Engineer and the annexures enclosed thereto, and regard being had to the communication dated 27.04.2015 Annexure-R-1 recording the factum of representations consideration of petitioners Annexures-A to A-4 to the writ petition, in compliance with the order dated 14.10.2014 we find no case made out. Infact the copy of communication of the Sub-Post Master marked as Annexure-R-2 in the affidavit discloses that the registered article was delivered on 02.05.2015 to the complainant. In other words the communication dated 27.04.2015 Annexure-R-1 was

delivered to the complainant even before the filing of contempt petition on 16.12.2015 which aspect of the matter is suppressed by the petitioner. Although learned counsel for respondent submits that costs be imposed for suppression of relevant material facts, we think it not appropriate to impose costs. Petition dismissed.
