And it is further ordered and decreed that the insurer to deposit the award amount within three months.

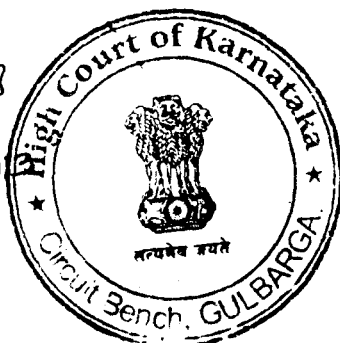
And it is further ordered and decreed that there shall be no order as to costs in this Appeal.
