CONCILIATION ORDER

After due deliberations, the parties have arrived at a settlement. The appellant-claimant has agreed to receive and the respondent - Insurance Company has agreed to pay global compensation of Rs1,10,000/-(Rupees One Lakh Ten Thousand Only) in addition to what has been awarded by the Tribunal, towards full and final settlement of the claim. A joint memo is filed on behalf of the parties to that effect. However, this order is subject to approval of the Respondent authorities.

- 2. The respondent Insurance Company has agreed to deposit the said amount before the Tribunal, within six weeks from the date of preparation of the award, failing which, the said amount shall carry interest at 9% p.a. from the date of default, till the date of deposit.
- 3. Entire amount awarded shall be released in favour of the appellant on proper identification.
- 4. Accordingly, Miscellaneous First Appeal stands disposed of in terms of the Joint Memo. The award of the Tribunal shall stands modified. Draw award accordingly.
