ORDER

Shri Mallikarjun C. Basareddy, learned Government Advocate accepts notice for respondent No.1.

- 2. Smt. N. Manjushree, IAS, Director, Directorate of Municipal Administration, Bengaluru - Accused No.1 has filed compliance affidavit dated 04.10.2023 stating thus:
 - "3. I submit that the petitioner has given a representation on 03.12.2023 seeking appointment under compassionate grounds. I state that after detail perusal of the records, it is found that the petitioner's date of birth as 06.06.1968. And that the Petitioner belongs to backward class community. As per the Compassionate appointment Rules, 1996, rule 4(2), the age limit for appointment is 36 years.
 - 4. I submit that after perusal of the records in the file, an endorsement Dated 22.09.2023 is issued to the petitioner. The copy of the endorsement dated 22.09.2023 is herewith produced as Document No.R-1 for the kind

perusal of this Hon'ble Court. I submit that as per the orders of this Hon'ble Court the Petitioner's case was considered as per the directions of this Hon'ble Court.

- 6. I humbly submit that I have highest respect for the orders of the Hon'ble Court and there is some delay in complying with the orders of this Hon'ble Court and same is due to administrative exigencies. The same may be condoned and contempt petition may be dropped, in view of the compliance of the orders."
- 3. Accused No.1 having already issued Endorsement dated 22.09.2023, nothing further survives and this CCC is closed.
- Learned Government Advocate is permitted to file 4. memo of appearance within eight weeks.
