THIS WRIT PETITION IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA, PRAYING TO ISSUE A WRIT /ORDER / DIRECTIONS IN THE NATURE OF CERTIORARI/ MANDAMUS DIRECTING THE RESPONDENT NO.3 - TAHASILDAR BASAVAKALYAN TO DELETE THE NAME OF RESPONDENT NO.4 - THE WAKF BOARD I.E. ಕರ್ನಾಟಕ ವಕ್ಷ ಮಂಡಳಿ ರರ್ಗಾ {ವಿಸ್ತೀರ್ಣ 36–15 ಗುಂಟೆ} APPEARING IN COLM.NO.11 OF RORS OF LAND SY.NO. 27/2 MEASURING 18 ACRES 22 GUNTAS SITUATED AT VILLAGE KONINOOR IN BASAVAKALYAN TALUK OF BIDAR DISTRICT FROM 2014-15 TO 2023-24 COLLECTIVELY SHOWN IN ANNEXURE-B (1) TO B(9).

THIS WRIT PETITION IS COMING ON FOR PRELIMINARY HEARING IN 'B' GROUP, THIS DAY, THE COURT MADE THE FOLLOWING:

#### **ORDER**

Heard Sri Faizuddin K. Zardi, learned counsel for the petitioner, Sri P.S.Malipatil, learned counsel for respondent No.4 and Smt.Maya T.R., learned High Court Government Pleader for respondent Nos.1 to 3.

- 2. The writ petition is filed with the following prayer:
  - A) issue a writ/order/mandamus or writ of certiorari Tahsildar, directing the respondent No.3-



Basavakalyan to delete the name of respondent NO.4- ಕರ್ನಾಟಕ ವಕ್ಷ ಮಂಡಳಿ ದರ್ಗಾ (ವಿಸ್ತೀರ್ಣ 36–15 ಗುಂಟೆ) appearing in colm.No.11 of RoRs of land Sy No.27/2 measuring 18 acres 22 guntas situated at village Kohinoor in Basavakalyan taluk of Bidar district from 2014-15 to 2023-24 collectively shown in annexure-B(1) to B(9)."

- 3. The writ petitioner's land has been shown as Waqf property in Column 11 of the RTC in respect of the land bearing Sy.No.27/2 measuring 18 acres 22 guntas situated at Kohinoor village, Basava Kalayana, Bidar District.
- 4. Admittedly, no notice has been issued to the petitioner nor any enquiry is held by the Tahsildar before entering the name of the Wagf Board in the RTC.
- 5. Therefore, a case is made out to quash the Orders at Annexures-B(1) to B(9) and remit the matter to the Tahsildar for fresh enquiry, after notifying the petitioner.
- 6. Hence, the following:

### **ORDER**

(i) Writ petition is **allowed**.

- (II) Annexures-B(1) to B(9) are quashed.
- (iii) The matter is remitted to the Tahsildar, Basava Kalyana, to hold fresh enquiry, after notifying the petitioner, in accordance with law, within a period of three months from today.
