This writ petition is filed for police protection. The petitioner is engaged in sale of construction materials like cement, steel bars, brick, sand etc. The petitioner's private concern is working in the area of Nalukoottam, Chathurthiakary in Alappuzha District. The above area is not a scheme covered area as per the Kerala Headload Workers Act, 1978. The respondents 6 to 9 are regularly engaged by the shop owners in the locality including the petitioner for doing necessary loading and unloading works. It appears that there are some dispute between the petitioner and respondents 6 to 9.

2. In such circumstances, it is appropriate that the police shall maintain law and order to ensure that no obstruction is caused to the petitioner from the side of

respondents 6 to 9 or others for loading and unloading activities to run his business.

The writ petition is disposed of as above.
