JUDGMENT

The petitioner assails the 'voters list' stated to have been settled by the $4^{\rm th}$ respondent – Returning Officer qua the elections to be conducted to the $1^{\rm st}$ respondent – Shakha, on various grounds, including that it contains the names of dead persons and has duplications.

- 2. Sri.Rajan Babu learned Standing Counsel for respondents 1 to 3, in response, submitted that the elections are now over, because this Court did not grant any interim order to the petitioner; and consequently, that the petitioner's remedy now is to challenge the elections through alternative means appropriately.
- 3. Smt.K.K.Sheeba learned counsel for the petitioner also affirmed that the elections are now over; and therefore, sought liberty for her client to challenge the same appropriately, through the competent Forum.

In the afore circumstances, this writ petition is closed, without entering into the merits of any of the rival contentions and leaving open all of them, for the petitioner to impel through appropriate Forums, if he is so interested.
