## ORDER

Petition filed under Section 438 Cr.P.C.

- 2. The petitioner is the 3<sup>rd</sup> accused in Crime No. 565/2014 of Nedumangad Police Station, which has been registered for the offences under sections 294(b), 324, 326 and 427 IPC.
- 3. The allegation against him is that he, along with co-accused, assaulted the first informant and another with a stick causing injuries including fracture.
- 4. Heard the learned counsel for the petitioner and the learned Public Prosecutor.
- 5. It is submitted by the learned counsel for the petitioner that he was known to the first informant; still his name was not revealed in the F.I. Statement or even in the subsequent statement and the allegation against him is false.

- 6. It appears that there are some suspicious circumstances in this case so far as the petitioner is concerned. Moreover, the first and second accused have been arrested and the weapon has been recovered. In the circumstances, I am inclined to grant his prayer.
  - 7. In the result, this application is allowed.
  - i. The petitioner shall be released on bail on his executing a bond for Rs.25,000/-(Rupees Twenty Five thousand only) with two solvent sureties each for the like sum if he is arrested by the Police in connection with this case.
  - ii. He shall appear before the Investigating Officer between 11.00 am and 12.00 noon on every Fridays for three months or till the final report is filed, whichever is earlier.
  - iii. He shall not get himself involved in any other criminal case while he is on bail.
  - iv. He shall not influence or threaten the witnesses.

This order is not applicable if the petitioner chooses to surrender before the Magistrate concerned and in such case the learned Magistrate may take appropriate action in accordance with the law.
