The appellant herein is the petitioner and the respondent is the respondent in O.P.No.637 of 2018 on the file of the Family Court, Thalassery. The above O.P was filed at the instance of the appellant herein seeking divorce under the Hindu Marriage Act.

2. Pending appeal, parties resolved their disputes in mediation. Based on the settlement, parties agreed for filing a joint petition invoking Section 13B of the Hindu Marriage Act before the Family Court, Thalassery, for divorce on mutual consent. The appellant has also agreed to pay a sum of Rs.2,50,000/- to the respondent on the day of evidence to the respondent in the proposed petition filed under Section 13B of the Hindu Marriage Act. There are also settlement in regard to pending matters. It is also

recorded that respondent received all gold ornaments.
