J U D G M E N T

The petitioner is the owner in possession of property having an extent of 2 Ares 46.8 Sq.Mts of land comprised in Sy.No.7/48 in Block No.002 of Pantheerankavu Village in Kozhikode Taluk in Kozhikode District. The grievance of the petitioner is that, the said property is described as 'Nanja' in the revenue records even though the same was excluded from the Data Bank. Therefore, an application in Form 6 which is produced as Ext.P2, has been submitted by him, before the 1st respondent, and it is now pending consideration since 01.02.2025. The limited prayer sought by the petitioner is to direct the 1st respondent to pass orders thereon within a time frame.

After hearing the learned counsel for the petitioner and the learned Government Pleader, I am inclined to dispose of this writ petition. Accordingly it is ordered that, the 6th respondent shall forward a report as to the nature of the property of the petitioner, to the 1st respondent, the authorized officer under Section 2(xvA) of the Kerala
