# **JUDGMENT**

The learned counsel for the respondent Railways submits that the direction given by this Court as per Annexure A1 judgment dated 17.03.2015 has been complied with and the position has been communicated to the petitioner as well. The learned counsel also points out that the delay in finalizing the proceedings was more because of the mistake committed by the petitioner, in so far as the address of the Chief Engineer was shown as at 'Kayamkulam', instead of 'Ernakulam'. The said mistake was realized and the petitioner got it corrected only much later, as per order dated 21.01.2016 in I.A. No.16600 of 2015. It is pointed out that certified copy of the verdict passed in the writ petition was initially forwarded to the Chief Engineer 'Kayamkulam' and after getting the same corrected, a copy of the same was forwarded to the competent authority. It is stated that immediately on receiving the verdict, steps have been taken to comply with the verdict and that the matter stands finalized.
