- (2) To mould the relief in the interest of justice due to change in circumstances and/or by efflux of time and grant such appropriate moulded relief to the petitioner.
- То grant such other appropriate relief/reliefs as the petitioner may pray for from time to time and which this Hon'ble Court may deem fit and proper to grant in the interest of justice."[SIC]
- 2. When this writ petition for came consideration on 18.02.2022, this Court passed the following order:

"Admit.

Petitioners to take out notice to respondents 1 and

2 by e-mail today itself. Learned Government Pleader takes notice for the 3rd respondent and seeks time to get instructions.

In view of the contention that the petitioners have not either surrendered their properties for road widening or being paid in compensation for acquisition of their properties, there will be a direction to the respondents to maintain status quo with regard to the properties of the petitioners for a period of 2 weeks."

3. The main prayer in the writ petition is to issue direction not to forcibly take the proprieties of the petitioners or to commit any act of waste or damage thereupon other than through due process of law. In the light of the interim order passed by this Court, nothing survives in this case. Even though notice is issued to respondents 1 and 2, there is no appearance for respondents 1 and 2. In such circumstances, the interim order dated 18.02.2022 can be made absolute.

Therefore, this writ petition is disposed of making the interim order dated 18.02.2022 absolute.
