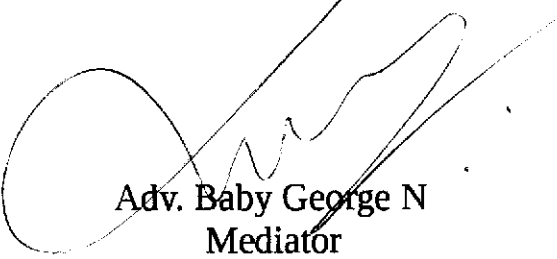

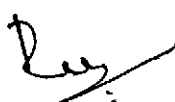

The LAA Nos.12/2023, 19/2023 and 45/2023 are filed by the Special Tahsildar, Spl. Tahsildar (LA) KINFRA, Palakkad, against the judgment and decree in LAR No.32/2012, LAR No.25/2012 and LAR No.38/2012 passed by the Sub Court, Ottappalam.

In LAR No.32/2012, the Sub Court enhanced the land value from Rs.11,362/- per cent to Rs.35,000/- per cent.

In LAR No.25/2012, the Sub Court enhanced the land value from Rs.10,000/- per cent to Rs.35,000/- per cent.

In LAR No.38/2012, the Sub Court enhanced the land value from Rs.10,000/- per cent to Rs.35,000/- per cent.

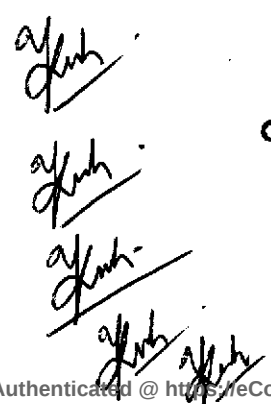
For rocky area, the land value enhanced from Rs.200/- per cent to Rs.10,000/- per cent.

After filing the above LA Appeals, there was a proposal to settle the cases by mediation. Accordingly, the Principal Secretary, Department of Industries, Government of Kerala issued an order dated 10.7.2023 with No.G1/173/2022 Ind. directing to constitute a team for mediation talk with the land owners/claimants. Thereafter, the District Collector, Palakkad appointed a team of officers for mediation talk with the land owners. In the mediation, there was an understanding between the parties regarding the terms of settlement of the cases and the same was sent to Department of Industries for approval. In the meanwhile the above cases were referred by the Hon'ble High Court of Kerala for mediation.

Now the Department of Industries, Government of Kerala has approved the terms and conditions for determining the compensation amount and the payment of the same to the claimants/land owners as per Government order with No.GO(Rt) No.944/2023/ID dated 15.9.2023. Now in the mediation on 19.09.2023, the parties in the above LA Appeals, LAA Nos.12/2023, 19/2023 and 45/2023 agreed to settle the cases as per the following terms and conditions, which is also approved by the Department of Industries, Government of Kerala as per GO (Rt) No.944/2023/ID dated 15.9.2023.

1. All the parties agreed to re-determine the compensation amount on the basis of the following terms and conditions.

2. For the purpose of determining the compensation amount, the value of the acquired land per cent will be calculated from the amount obtained by deducting Rs.50 lakhs from the total compensation fixed by the Sub Court, Ottapalam in LAR 25 of 2012, LAR. No.32 of 2012 and LAR No.38 of 2012.

So that the land value for determining the compensation is @ Rs.34,559/- per cent and for rocky area it is @ Rs.10,000/- per cent.

3. The land owners/claimants in the above cases agreed to waive the interest for the period from 20.3.2015 to 5.3.2021 (2178 days), the period of stay granted by the Hon'ble High Court of Kerala in O.P (C)No.709 of 2015.

4. The land owners/claimants also agreed to limit the interest for the compensation amount upto 31.3.2023.
