- ii. issue a writ of mandamus or any other appropriate writ, order or direction, commanding the respondents to revise/re-fix the time bound higher grade of petitioners in the cadre of Clerk, by reckoning the last grade service rendered by them, and to sanction and disburse the consequential benefits, forthwith:
- iii. issue a writ of mandamus or any other appropriate writ, order or direction commanding the 1st respondent to consider and dispose of Ext P44 representation, in the light of Ext P38 order of the Government, forthwith, with notice to the petitioners;
- iv. issue such other writ, order or direction which may deem fit in the facts and circumstances of the case" [SIC]
- 2. Today, when the matter came up for consideration, the learned counsel for the petitioners submitted that there may be a direction to consider Ext.P44 within a time frame, in

the light of Ext.P36.
