### **JUDGMENT**

Dated this the 6<sup>th</sup> day of March, 2023

The petitioner, an unemployed graduate who has been diagnosed with Brain, Bipolar Affective Disorder with 40% PPI/Disability, has approached this Court seeking to call for the records relating to the application of the petitioner for the post of Lower Division Clerk for the District of Kasaragod and to set aside the orders rejecting the claim of appointment of the petitioner in the sub category locomotor disability/cerebral palsy.

2. To a pointed question, counsel for the petitioner submitted that the ultimate relief received by the petitioner will be appointment to Government service as a Lower Division Clerk. The petitioner has sought to declare that the petitioner is entitled for appointment under reservation category locomotor disability/cerebral palsy in the light of the Rights of Persons with Disabilities Act, 2016 and order to include him in

the list of eligible candidates for appointing for the sub category and direct respondents 2 and 3 to appoint the petitioner in a suitable post available at present or expected in future. The reliefs relate to appointment to Government service.

3. In view of the said fact and in view of the provisions contained in the Administrative Tribunals Act, 1985, the issue being a service matter, the petitioner has to approach the competent Tribunal constituted under the Administrative Tribunals Act, 1985.

In the circumstances, granting liberty to the petitioner to approach the competent Tribunal, this writ petition is dismissed.
