JUDGMENT

Dated this the 17th day of February, 2025

The petitioner, who is working as Permanent Labourer in Kerala Veterinary and Animal Science University, has filed this writ petition seeking the following reliefs:

- (i) Issue a writ of mandamus or any other appropriate writ, order or direction commanding the respondents to grant admission to the petitioner to the course 'Diploma in Live Stock Farm Management' based on her marks in the entrance exam for admission to the course 'Diploma in Live Stock Farm Management'
- (ii) Declare that in view Ext.P5 Circular dated 08.01.2025 and in view of Ext.P6 main list published by the 1st respondent, the 1st respondent has waived the ineligibility casted on the petitioner among other persons as per Ext.P2 for joined course while in service
- (iii) Or in the alternative, issue a writ of certiorari or any other appropriate writ, order or direction quashing Ext.P2 Circular No.KVASUGA/A3/4184 /2024 (9) dated 20.12.2024 so far as it excludes the petitioners from figuring in the final list of candidates eligible to appear for entrance examination for the Course 'Diploma in Live Stock Farm Management' conducted by the 1st respondent University.

2. In a similar matter, this Court delivered judgment in W.P.(C) No.46678/2024 and connected cases, wherein this Court observed as follows:

4. Taking into consideration the facts of the case, I am of the view that the issue whether the petitioners are eligible for admission to the Diploma in Livestock Farm Management Course as they claimed to have obtained higher qualification prior to Ext.P3 communication dated 10.03.2021, is a matter to be looked into by the respondents. I am of the view that if there was no embargo on University employees undergoing higher education without prior permission, prior to Ext.P3, indeed the petitioners cannot be denied the benefit of admission to the Diploma in Livestock Farm Management Course.

As the petitioner is similarly situated, this writ petition is disposed of directing the 2nd respondent to consider the eligibility of the petitioner for admission to the Diploma in Livestock Farm Management Course taking note of the fact that the petitioner claims to have acquired qualifications prior to issuance of Ext.P3. The petitioner shall produce all relevant documents in this regard before the Registrar within a period

of two days. The Registrar shall take appropriate decision at the earliest and at any rate before finalising the admission to the Course.
