JUDGMENT

Vinod Chandran, J.

The child is produced by the petitioner himself before us. It is submitted that the Police had resumed the custody of the child to the petitioner.

- 2. We have heard the learned counsel for the petitioner and also the learned counsel appearing for the $4^{\rm th}$ respondent.
- 3. The learned counsel for the $4^{\rm th}$ respondent submits that his client has told him that there was some misbehaviour alleged on the brother-in-law of the petitioner, for which a complaint was also raised the very next day. Admittedly, the petitioner was not on very good terms with the $4^{\rm th}$ respondent, the mother-in-law. The petitioner's wife, who is the mother of the minor child, is said to be no more, having

committed suicide in the house of the 4th respondent.

The petitioner, who was abroad had come back and 4. had also after the last rites of his wife, stayed with the 4th respondent and his child. Later, the child was taken to his house. The 4th respondent is said to have come to the petitioner's house to take the child back, which was refused. Upon which, the complaint was raised. A copy of the complaint also is produced before us, which is marked as Ext.C1. The complaint alleges that the child was troubled by the brother-in-law of the petitioner, when the child was sleeping with the grandmother. We are *prima facie* not ready to take the allegation at its face value. However, we say nothing further on the complaint. No certified copy shall be issued of the abovesaid document unless orders from this Court is obtained.

We saw the child interacting very well with the father. Since the child has been restored to the custody of the father, we are of the opinion that the writ petition can be disposed of, W.P.(Crl.)No.228 of 2022

leaving open the remedy of the grandmother, to approach the appropriate court for the custody of the child, if so desirous.
