ORDER

The petitioners are accused in Crime No.183/2016 of Pazhayangadi police station for offences punishable under sections 143,147,148,341,323,324 read with section 149 IPC. The matter is now pending as CC No.700/2016 of the Judicial First Class Magistrate Court, Payyannur.

- 2. The second and third respondents alleged that, on 6/2/2016 at 10.p.m. the accused attacked the defacto complainants and caused bodily injuries armed with iron pipe. Pending the proceedings, parties are stated to have resolved their disputes.
- 3. The second and third respondents have filed separate affidavits as Annexures 3 and 4. Learned counsel for respondents 2 & 3 submitted that the averments contained in Annexures 3 and 4 are correct and that, they have no objection in quashing the proceedings. It was further submitted that since the second respondent is a minor, the affidavit is sworn to by her mother.
- 5. Learned Public Prosecutor, on instructions, submitted that the petitioners are not involved in any other crime and the dispute between the parties have been settled.
