JUDGMENT*(Dated: 3rd July, 2024)*

The question involved in all the writ petitions concerns the certificates produced as a minimum qualification for the post of Lower Division Clerk in Kerala State Co-operative Coir Marketing Federation Ltd., in which 50% of the vacancies are reserved for the members of the society affiliated to Coir Fed as per Rule 187 of Kerala State Co-operative Societies Rules, 1969.

2. W.P.(C) No.7437 of 2023 is taken as the leading case. The case of the petitioner is as follows. The petitioner is a Paid Secretary and member of the Kerala State Co-operative Coir Marketing Federation Ltd., The petitioner possesses a Bachelor of Arts and a diploma in Computer Teacher Training awarded by the Centre for Development of Imaging Technology (C-DIT), which is under the Government of Kerala, with a Higher Diploma in Co-operation and Business Management awarded by the Central Board

of Examination, State Co-operative Union, Kerala. While so, Ext.P7 notification was published in the extraordinary Gazette on 03.04.2021 for the post of Lower Division Clerk.

The minimum qualifications required for the post are:

1) Must have 3 years of regular service in any cadre in the Member Society affiliated to the Kerala State Co-operative Coir Marketing Federation Limited and should be in service of the Member Society not only on the date of application but also the date of appointment to the new post.

2) (A) A Degree in Commerce or Degree of a recognized University with Co-operation as special subject. OR

(B) (i) B.A./B.Sc./B.Com. Degree (3 years) of a recognized University and

(ii) HDC or equivalent (HDC or equivalent of State Co-operative Union of Kerala or HDC/HDCM of the National Council for Co-operative Training) or Successful completion of the Subordinate (Junior) Personnel Co-operative Training Course (JDC) OR

(C) B.Sc (Co-operation and Banking) Degree of Kerala Agricultural University

3) A certificate in Computer Application/Data Entry issued by an Institution recognized by Government of Kerala or Government of India.

3. The petitioners participated in the test, but in the shortlist published, the petitioners names were not included.

Therefore, the petitioners approached this Court to quash Ext.P9

and to declare that the petitioners are fully qualified to be appointed as L.D.Clerk, taking into consideration Exts.P3 and P5 certificates.

4. A counter affidavit is filed by respondents 3 and 4, stating that the Kerala Public Service Commission (short KPSC) has issued a notification dated 03.04.2021, inviting candidates with requisite qualifications to the post of L.D.Clerk in the 2nd respondent. One of the qualifications prescribed is a “Certificate in Computer Application /Data Entry” issued by an institution recognized by Government of Kerala or Government of India. The certificate produced by the petitioners is in “Diploma in Computer Teachers Training”, a course conducted by the Centre for Development of Imaging Technology(C-DIT). The Commission cannot accept the said certificate for selection. The required qualifications for the post have been considered in depth by the Commission and the Government; after obtaining a report from the

Director of Technical Education, the Government has issued GO(MS) 44/2012/P&ARD dated 10.09.2012 accepting 13 courses conducted by the Government approved autonomous agencies as equivalent to or alternate qualification DCA for selection to the post of Assistant to Government Secretariat, Kerala Public Service Commission Etc., Government has also passed another G.O. Rt 160/2012/ID dated 29.12.2012 accepted additional courses as well, as equivalent and Routronix, the Government of Kerala undertaking was to authorise to conduct 10 posts which are detailed in the counter affidavit.

5. In G.O.(MS) 25/2012/P&ARD dated 26.05.2012, it is stated that the diploma in computer application should be obtained after the course of study with not less than 6 months duration or its equivalent recognised by the Government. The above Government order identifies the DCA courses conducted by IHRD, LBS, Routronix, C-DIT, C-DAC, C-APT, KELTRON, as a qualification for selection to the

post of Assistant in Government Secretariat and KPSC etc., Ext.R3(a) is the Government Order produced, which accepts 13 courses, which are equivalent to DCA for selection to the post of Assistant in Government Secretariat, KPSC etc., A statement is filed by the 1st respondent in W.P.(C) No.7211 of 2013, and an adoption memo is filed to accept the same in this writ petition also.

6. The government's stand is that the recruitment criteria for all posts in COIRFED, except the post of Managing Director, are finalised after consulting with COIRFED. It is true that the workload assigned to an L.D. Clerks do not demand vast knowledge of computer applications; they just need a minimum level of knowledge and technical understanding by fixing the additional qualification to the post of L.D.Clerk, the management desired that such a person would have added knowledge about the software, hardware, internet navigation, etc., in addition to basic knowledge of data entry operations and word processing methods. It is also

submitted that the recognition of the posts as equivalent to the post with the recognized course can only be examined by the appropriate authority. The petitioners in the writ petitions have not moved to the appropriate authority till date. Therefore, the writ petitions are devoid of merits and are liable to be dismissed.

7. The only question to be considered is whether the certificates produced by the petitioners herein obtained from various institutions, which are either recognised by the Government of Kerala or by the Government of India, can be accepted as minimum qualification prescribed in the notification to the post of L.D.Clerk in the Kerala State Co-operative Coir Marketing Federation Ltd., One of the minimum qualification prescribes that a certificate in Computer Application/Data Entry issued by the institution recognised by the Government of Kerala or by the Government of India is enough. All the petitioners in the writ petitions have either Diplomas or certificates from various institutions recognised by the

Government of Kerala or by the Government of India.

8. The stand of the Kerala Public Service Commission is that the certificates produced by the petitioners as minimum educational qualifications cannot be accepted as the same is not in the list approved by the Government as per G.O.Rt 160/2012/ID dated 29.12.2012. The acceptance of the certificates of the petitioners was never before the Government. The PSC is bound to follow the orders passed by the government with respect to the minimum qualifications prescribed in the notification. If there is any ambiguity or doubt regarding the particular qualification, the appropriate authority or the government must take final order. Admittedly, the petitioners either have a Certificate or Diploma in Computer Applications recognised by the State Government or the Central Government. In such a scenario, it is for the 1st respondent to take up the issue with the competent committee of technical experts to see whether the qualifications

can be accepted on par with the qualification prescribed in the notification, as the certificate in Computer Application/ Data Entry issued by the institutions recognised by the Government of Kerala or Government of India.

Therefore, the 1st respondent is directed to constitute a committee with the experts in the field of computer applications to consult with the PSC and take a decision with respect to the different certificate courses as well as diplomas which can be accepted as minimum qualifications prescribed in Ext.P7 notification to the post of L.D.Clerk in COIRFED. This exercise shall be completed within a period of four months from the date of receipt of a copy of the judgment. Needless to say, the petitioners shall be given an opportunity of hearing before orders are passed.
