# **JUDGMENT**

Dated this the 23rd day of January, 2025

The petitioner, who studied MBBS Degree Course in the 4<sup>th</sup> respondent-College, has filed this writ petition seeking to direct respondents 1 and 2 to allow the petitioner to register for the theory examination notified by Ext.P2 and scheduled by Ext.P3 and to allow her to write the examination in terms of Ext.P3.

- 2. The further prayer of the petitioner is to direct respondents 4 and 5 to forward the attendance and internal assessment of the petitioner to the 1<sup>st</sup> respondent-University.
- 3. It is admitted by either side that during the pendency of the writ petition, all requisite records have been forwarded by the College to the University and the University has

issued necessary Certificates and intimation to the College. After completing the House Surgency, the University has issued MBBS Completion Certificate also to the 4<sup>th</sup> respondent-College, submits the counsel for the petitioner.

- 4. Standing Counsel representing respondents 4 and 5 submitted that there is a short payment of ₹10,31,710/-towards fee by the petitioner.
- 5. The petitioner vehemently dispute the same and would submit that while getting admission in the College, the petitioner has paid ₹30 lakhs and an amount of ₹10 lakhs more is liable to be adjusted towards the last year fee of the petitioner. ₹20 lakhs has been adjusted towards the fee of the 2<sup>nd</sup> year. Standing Counsel for respondents 4 and 5 dispute the same.
- 6. Going through the pleadings in the writ petition and after hearing the arguments of the petitioner and the respondents, I am of the view that the issue remaining is only release of necessary Certificates to the petitioner and the dispute

regarding the payment of fee.

- 7. It is now settled law that Educational Institutions are not entitled to withhold Certificates and other documents of the students, for want of payment of fees. In the circumstances, I am of the view that the writ petition can be disposed of with the following directions:
  - (i) Respondents 4 and 5 are directed to the **MBBS** Completion release Course Certificate. CRRI Certificate. Second Provisional Certificate, Mark List for all the Transfer Certificate, Conduct years, Certificate and originals of 10th Standard Certificate and Plus Two Certificate to the petitioner within two weeks.
  - (ii) In the meanwhile, if respondents 4 and 5 approach the 3<sup>rd</sup> respondent for adjudication of balance fee payable by the petitioner, the
