JUDGMENT

[WP(C) Nos.72/2022, 9366/2022, 9400/2022]

It may not be necessary for this Court to write a long judgment in these matters, because the interim order, earlier granted by a learned Judge of this Court in W.P.(C)No.72/2022, would more or less cover the field finally.

2. For such reason, I deem it appropriate to extract the interim order dated 16.03.2022 as under:

"I have heard Nuriya O.A, the learned counsel appearing for the petitioner, Sri.K.C.Santhosh Kumar, the learned counsel appearing for the College, Sri.S.Manu, the learned Standing Counsel and Sri.P.Sreekumar, the learned Standing counsel appearing for the KUHS.

2. The petitioners 1 to 3 are Non Keralite Category (NKII category) students of the 2016-2017 Batch and petitioners 4 and 5 are similar category students of the 2017-2018 batch pursuing their BSMS Course in the 3rd respondent College.

3. The admission of the petitioners and students similarly situated was withheld by the Admission Supervisory Committee on the ground that the students did not write any common entrance

examination. It was only after several rounds of litigation that it was realized that during the relevant period, the students outside the State of Kerala had no obligation to write either the Kerala Entrance Examination or the NEET. This Court by Ext.P3 judgment had directed the Government to reconsider the issue. The Government, after considering the entire aspects had ordered the regularisation of admission and later by Ext.P7 and P8 orders, ASC had directed the KUHS to register the students the details of which are mentioned in the order. In pursuance to the same, Ext.P9 order has been passed by the KUHS directing the students to apply for continuation of break of study individually for continuing their studies. The grievance of the petitioners concerns the said order.

4. Sri.P.Sreekumar, the learned Standing Counsel appearing for the KUHS submitted that insofar as the petitioners 1 to 3 are concerned, they are bound by the 2013 regulations and insofar as the petitioners 4 and 5 are concerned, the regulations 2016 would apply. It is submitted that only based on directions issued by the 2nd respondent can the University take a decision insofar as relief (2) sought for in the writ petition is concerned.

5. The learned CGC submits that he is yet to receive instructions as to whether in the peculiar facts and circumstances and in view of the sequence of events the benefit of 2016 regulations can be extended to the petitioners. He seeks an adjournment.

6. In view of the facts and circumstances and taking note of the entire sequence of events, I am of the view, as an

interim measure, directions can be issued to the respondents to permit the petitioners to provisionally appear for the examinations as prayed for.

7. *The respondents shall permit*

a) The 1st and 2nd petitioners to register and write the second year and third year BSMS degree examinations as per notifications dated 18.2.2022 and 28.2.2022 respectively.

b) The 3rd petitioner shall be permitted to write the first and second year BSMS Degree examinations as per notifications dated 18.2.2022 and 28.2.2022 respectively.

c) The 4th and 5th petitioners shall be permitted to register and write the first and second year BSMS Degree examinations as per notifications dated 28.2.2022 and 18.2.2022 respectively.

The results shall be published only after securing orders from this Court."

3. The sole remaining controversy at this stage, as is evident from the afore interim order, is whether the University Regulations, 2016, namely Ext.P22, would govern the petitioners; and this is an issue which will have to be answered by the competent Authority of the Government of India.

4. The learned Central Government Counsel, Sri.T.V.Vinu, submitted that the question whether the benefits under University Regulations, 2016, can be made applicable to the petitioners herein as a special case and decided by this Court appropriately; however, praying that it may be clarified that this will not be construed as a precedent in future. He explained that the position of the official respondents is that, normally, the University Regulations, 2016, cannot be applied to the petitioners; but that, taking note of peculiar circumstances involved in this case and the interim order as afore, as also the fact that they are continuing their course, any benefit under the said Regulations will not be opposed as far as it is made exclusively for them and no one else.

5. Sri.P.Sreekumar - learned Standing Counsel for the University, on hearing the learned Central

Government Counsel as afore, submitted that if this be so, then certainly the petitioners can be allowed to complete their course and take their examinations, subject to other imperative and mandatory requirements under the University Regulations, 2016, being complied with. He submitted that, therefore, the petitioners will have to now make an application for condonation of their break in study, which will certainly be considered by the University in terms of law and going by the mandate of the said Regulations.

In the afore circumstances, I order these writ petitions, granting liberty to the petitioners to approach the competent Authority of the University with apposite applications seeking condonation of their break in study; and if this is done within a period of two weeks from the date of receipt of a copy of this judgment, same shall be considered by the said Authority strictly in terms of the

University Regulations, 2016; and the resultant order be issued to them without any avoidable delay.

Needless to say, on condonation of the break in study being so allowed, the petitioners will be eligible to complete the course and to write the examinations, subject to all other requisite and mandatory requirements being satisfied and complied with under the University Regulations, 2016.

I make it clear that afore directions have been issued, without entering into the merits of the contentions of the rival parties and taking note of the peculiar circumstances and the facts in this case, as also the concessions fairly made by the stakeholders; and therefore, that this will not apply as a precedent to any other case in future.

As a consequence of the afore directions, it

also goes without saying that results of the examinations taken by the petitioners shall be published by the University on their completion of the course; thus further ordering that the afore extracted interim order will stand confirmed.
