## **JUDGMENT**

The prayer in the writ petition is to permit the petitioner to pay off the amounts due to the respondents in easy instalments. The Standing Counsel for the respondents on instructions submits that the amount due is Rs.25,68,894/-. It is also submitted that they have no objection in permitting the petitioner to pay off the amounts in instalments, provided the payments are made regularly and the future interest is also paid.

In the above circumstances, the writ petition is disposed of directing the petitioner to pay off the amount of Rs.25,68,894/- along with interest and cost in 12 equal monthly instalments, the first instalment falling due on or before 04.05.2023 and the subsequent instalments falling due on or before the 4<sup>th</sup> of the succeeding months. If the petitioner makes a single default in the payment of instalments, as directed above the respondents will be at liberty to continue with coercive steps for recovery. The coercive steps initiated
