## ORDER/JUDGMENT

These two case are connected and therefore, I am disposing of these two cases by a common judgment.

2. The prayer in Crl.M.C. No. 6871/2023 is to quash Annexure-A3 order by which the learned Magistrate directed the Police to investigate the matter under Sec. 202 Cr.P.C. to collect sufficient materials including the statement of witness, documents etc. After going through the order, I am of the considered opinion that there is nothing to interfere with that order.

## O.P.(Crl.) No. 302 of 2023

O.P.(Crl.) is filed with following prayers :

- (i) "To direct the Hon'ble Judicial Magistrate Court No.III, Thrissur to pass orders on Ext.P1 CMP No.817/2021 within a time frame fixed by this Hon'ble Court.;
- (ii) To grant such other and further reliefs as this Hon'ble

Court may consider just and proper In the facts and circumstances of the case.

- (iii) The petitioner also prays that this Hon'ble Court may be pleased to dispense with the translation of the documents produced in the vernacular language." [SIC]
- 3. This petition is filed mainly for a direction to dispose the matter pending before the trial court. This Court directed the Registry to get a report. The learned Magistrate forwarded the report. The relevant portion of the same is extracted hereunder:

"With reference to the above, I may most humbly submit that the following for kind consideration.

2. CMP 817/21 is filed against the accused persons who are 4 in numbers, under Section 190 (1) (a) of Cr. P.C. On perusal of records, the last posting date of this case was on 06/05/2023 and on that day, my learned predecessor directing the SHO, Ollur

Police station to investigate the matter and file a report u/s. 202 Cr. P.C. and the next posting date is on 06/07/2023. CWI to CW4 were examined.

- 3. It is further submitted that, I took charge as Judicial First Class Magistrate in this court only on 20/05/2023. I may also submit that the pendency in this court is nearly 15,000. Considering the present stage of this case and also the pendency of this court, it is most humbly requested to kindly grant me 6 months time to dispose the above mentioned CMP."
- 4. From the above, the learned Magistrate submitted that six months time is necessary to dispose the matter. I think these cases can be disposed of directing to dispose the main case itself within six months.

Therefore, these cases are disposed of directing the Judicial First Class Magistrate Court-III, Thrissur to dispose CMP No. 817/2021 as expeditiously as possible, at any rate, within six months from today.
