JUDGMENT

The petitioners are faced with an award passed in the ARC proceedings in respect of a defaulted loan account. The award is under challenge in this writ petition.

- 2. Heard, learned Counsel on both sides.
- 3. On 05.04.2023, this Court had directed the petitioners to pay an amount of Rs.1,50,000/- (Rupees one lakh fifty thousand only) within one month. It is reported that, though belatedly, the said direction has been complied with by the petitioners.
- 4. The petitioners confine the relief for grant of an easy installment facility to wipe off the debt.
- 5. Considering the financial constraints pointed out by the petitioners and also the amount involved, I am of

the opinion that a reasonable installment facility can be granted.

6. The petitioners shall pay off the total amount due to the bank, with interest and costs, in 15 equal monthly installments commencing from 31.10.2023. In case of default in payment of any single installment, the petitioner will lose the benefit granted under this judgment.
