JUDGMENT

Though various issues and contentions have been raised and urged in these Writ Petitions – which have been heard together advertent to the similarity and analogous nature of the factual circumstances pleaded and that of the reliefs sought for - it became apparent that it will not require this Court to enter into the merits of such issues in detail, on account of certain events *lis pendens*.

2. Sri.P.Sreekumar – learned Standing Counsel for the University, explained the course and life of this litigation taking me through the various timelines, as also the several orders issued by this Court in the past.

3. Suffice to say, the petitioners were unfortunately misguided by certain information which they were exposed to the social media and they concede that they have not taken the ‘General Medicine’ and ‘General Surgery’ Examinations (two papers each) of the final year MBBS Course. The University,

however, takes the position that they do not want to penalise the petitioners or any other student for this faux pas, and that they are willing to offer them one more chance to clear the examinations in addition to the earlier ones offered and recorded by this Court. Sri.P.Sreekumar, their learned counsel, submitted that the supplementary examinations are scheduled to begin tentatively on 09.09.2022 (taking care to say that this date is subject to change) and that if the petitioners are so interested, they can take the said examinations, along with other papers, which will then be treated as first chance.

4. I, therefore, asked the learned counsel for the petitioners – Sri.Sreekumar G. Chelur, Sri.S.Shanavas Khan and Sri.Mahesh V. Ramakrishnan appearing in these cases and they affirmed that this is the best opportunity that their clients can have. They, however, made one last attempt before this Court to seek that a special examination be conducted earlier, asserting that their clients have now acquired necessary training for such purpose.

5. I must say that I am fully inclined to accept the afore

suggestion made by Sri.P.Sreekumar – learned Standing Counsel for the University, for two reasons. For the first, it is the case of the petitioners themselves in their pleadings in these cases that they have skipped the examinations because the training given to them by the respective colleges was deficient. Obviously, therefore, unless the training is now confirmed to be complete, a further chance at the examinations would be impossible. For the second, the petitioners themselves say that they have skipped the examination based on a wrong information obtained through the social media. I cannot find any cause to blame the University in this regard.

In the afore circumstances, I order these Writ Petitions recording the afore submissions of the learned Standing Counsel for the University; with a consequential direction to the University to permit the petitioners to take the examinations which are scheduled to be held on 09.09.2022, subject to all other statutory and imperative eligibility conditions being satisfied; and should they clear it, then it shall be treated as their ‘regular chance’.

After I dictated this part of the judgment, Sri.Sreekumar G. Chelur intervened to say that on account of the unfortunate events that his clients and others had to face - which have been chronicled in these Writ Petitions - the internet site of the University shows them as having 'failed'. He submitted that, in fact, this should not have been so since, as is evident from the afore submissions of the learned Standing Counsel for the University, if the students are to clear the examinations in September 2022, it will be construed as their 'regular chance'.

I find force in the afore submissions and am certain that the University must take repertory measures, particularly taking note of the afore directions, without any avoidable delay.

Needless to say, I leave liberty to the parties in these Writ Petitions to approach this Court again for any clarifications, if it becomes so warranted in future.
