JUDGMENT

The petitioners 1 to 4 are running a medical lab and medical shops while the 5th petitioner is running a stationery shop in the building constructed in Sy. No.40/39 of Chelavoor Village in Kozhikode Taluk. Exts.P1 to P5 are the licence deeds executed between them and the building owner. Exts. P6 to P8 are the trade licences issued to the petitioners. The grievance of the petitioners is that they are prevented from doing their business on account of a bunk shop installed by the additional 4th respondent in front of their shops preventing access and also the parking of the vehicles.

- 2. A counter affidavit has been filed on behalf of the Corporation wherein it is stated that they had not given any consent or licence to put up any temporary shed on either side of the road or in front of the shopping complex where the petitioners are running their business or in the property of PWD. It is also submitted by the Corporation that the land on which the bunk is put belongs to the additional 5th respondent, the Kerala Road Fund Board.
- 3. The additional 4th respondent has filed a statement contending that they have put up a small bunk without causing any difficulties to the petitioners and that the bunk has been in the same location for a very long time. It is also stated that they had preferred Ext.R4(a) application seeking for a licence before the Corporation. It is also submitted that the income from the bunk shop is the only

source of income for a family consisting of an old-aged mother, wife and two school-going daughters.

4. I have heard the learned counsel for the petitioners and the learned counsel appearing for the respondents.

After hearing both sides and taking note of the averments of the Corporation that the additional 4th respondent has installed the bunk without any licence and that the property on which the bunk is situated belongs to the Kerala Road Fund Board, it has to be held that the additional 4th respondent is in illegal occupation. It will be open to respondents 1, 2 and the additional 5th respondent to take appropriate steps against the additional 4th respondent for removing the structure from the place where it is currently situated. However, taking note of the contention of the additional 4th respondent that he has made an application to the Corporation seeking a licence, Ext.R4(a), the 1st respondent Corporation is directed to consider the same and pass appropriate orders so as to accommodate the additional 4th respondent in a location which does not cause inconvenience to anyone. The Corporation shall consider the same within four weeks from today. The action for removal of the bunk shall be taken only after the Corporation passes orders as directed above.

The writ petition is disposed of as above.
