JUDGMENT

The writ petition is filed to set aside Ext.P16 sale notice issued by the 3rd respondent - Authorised Officer under Section 8(5) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2202 (in short, "SARFAESI Act).

- 2. When the writ petition came up for consideration on 18.04.2023, this Court had directed the confirmation of sale, pursuant to Ext.P16 notice, to be deferred subject to the condition that the petitioner deposits an amount of Rs.25,00,000/- (Rupees Twenty five lakh only) within a period of three weeks.
- 3. Sri.Devaprasanth, the learned Standing Counsel appearing for the respondent submits that the petitioner has not complied with the above order.

In view of the fact that the petitioner has failed to comply with the conditional order passed by this Court,

and the law declared by the Honourable Supreme Court in South Indian Bank Ltd. & Ors. v. Naveen Mathew Philip & Anr. [2023 LiveLaw (SC) 320] I am not inclined to exercise the discretionary powers of this Court under Article 226 of the Constitution of India and further entertain the writ petition.

Resultantly, the writ petition is dismissed.
