# JUDGMENT

I heard Mr.B.S.Swathykumar, Advocate on behalf of the petitioner and Mr.K.Babu Rajan, Advocate on behalf of the respondents.

- 2. The only prayer pressed at the time of hearing is for an early consideration of an application for injunction filed restraining the defendants in the suit from convening or conducting annual general body meeting of the plaintiff company on 27-9-2012.
