THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 04.04.2022, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

Dated this the 4^{th} day of April, 2022

The petitioner was appointed as Attender on temporary basis at the NRHM-Ayurveda Dispensary, in Sooranad North Grama Panchayath on 20.01.2016 and continued in service uninterruptedly. Now the respondents are trying to replace the petitioner with a fresh hand. The writ petition is filed seeking a declaration that the petitioner is entitled to be retained as Attender in Sooranad North Ayurveda Dispensary as long as National Health Mission Scheme exists and that the petitioner cannot be replaced with another temporary hands.

2. Heard Advocates Maitreyi Sachchindananda Hegde for the petitioner, M.Ajay for respondents 2 and 3, K. Siju for respondents 4 to 7 and the Government Pleader, Premchand R Nair for the 8th

respondent.

- 3. Learned Counsel for the petitioner relied on various Government Orders to contend that, for the purpose of tackling the spread of Covid-19 pandemic, the Government had directed all Local Self Government Institutions to continue the service of temporary hands. Reliance is also placed on Ext.P6 in W.P.(C) No.4100/2021, wherein this Court has passed an interim order permitting the writ petitioner to continue in service.
- 4. Learned Standing Counsel for the Panchayath submitted that the Government Orders relied on by the petitioner are with respect to temporary hands appointed under MGNRE Scheme and hence, not applicable. It is contended that, being a temporary hand, the petitioner has no legal right to seek either continuance or regularisation.
- 5. Learned Counsel for respondents 1 and 2 pointed out that the National Health Mission and

Ministry of Health and Family Welfare are unnecessary parties, since there is no privity of contract between those respondents and the petitioner. Further, the role of respondents 2 and 3 is only to supplement the efforts taken by the Government in the Primary Health Sector.

In view of the Division Bench judgment writ appeal No.925/2021 dated 27.09.2021, rendered under similar circumstances, I deem it appropriate to dispose the writ petition, leaving the contention regarding applicability of Government Orders to be decided by the appropriate authority. The writ petition is hence disposed of, permitting the petitioner file a detailed representation before Director of Panchayaths along with certified copy of this judgment and relevant Government Orders. A copy of the representation along with documents shall be forwarded to the Panchayath Secretary and thereupon, the Panchayath Secretary also submit a detailed report shall before the Director of Panchayaths, touching upon the factual aspects and the applicability, otherwise, of the Government orders and Departmental Circulars. A copy of that report shall be furnished to the petitioner also. After receiving the Panchayath Secretary's

report, the Director of Panchayaths shall issue notice of hearing to the petitioner and the Secretary and decide the petitioner's claim for continuance in service. To effectuate an early decision in the matter, the petitioner shall file the representation within two weeks of receipt of a copy of this judgment and the Panchayath Secretary shall file the report within two weeks thereafter. The Director of Panchayaths pass final orders in the matter within one month of receipt of the Panchayath Secretary's report. Till a decision is taken by the Director of

Panchayats, the petitioner shall be allowed to continue in service.
