**J U D G M E N T**

Pius C. Kuriakose, J.

The petitioner, who is the mother of the 1<sup>st</sup> respondent and the wife of the 2<sup>nd</sup> respondent, challenges Ext.P4 award passed by a Lok Adalat organized by the District Legal Services Authority, Thrissur. Under Ext.P4 award, the petitioner and the 2<sup>nd</sup> respondent awarded monthly maintenance @ Rs.750/- from their son from 01.09.2011 onwards. Ext.P4 is challenged on various grounds.

We are not inclined to uphold the challenge as grounds did not appeal so. We decline the relief sought for in the OP. However, we permit the petitioner to move the appropriate Tribunal under the provisions of the Maintenance and Welfare of Parents and Senior Citizens Act and Rules if so advised or seek remedy under Section 127 of CrPC if available.

The original petition is disposed of as above.
