JUDGMENT

The above Writ Petition is filed with the following prayers:-

- i. To call for the records relating to Exhibit P-1 to P- 14 and to issue a writ of certiorari quashing Ext.P1 is an invalid order and to set aside the same and also set aside Ext.P7 as it is passed without taking into account Ext.P5 explanation submitted by the petitioners.
- ii. To issue writ of mandamus commanding the respondents 2 and 3 to approve the appointment of teachers appointed by the 1st petitioner as manager of the school without insisting that the appointment of the 1st petitioner as manager is approved

by the department and also taking into account previous sanction and approval and based upon defacto doctrine

iii. To issue writ of certiorari quashing rejection of appointment as per noting contained on the reverse side of Ext. P11, P12 and P13 as illegal and not valid.

iv. Any other reliefs may be granted as prayed at the time of argument and is deemed fit to be granted by this Hon'ble court.

- v. To dispense with filing of the translation of vernacular documents.
- 2. Exts. P1 and P7 are issued by the 2nd respondent. Therefore, I am of the considered opinion that, this Writ Petition need not be retained before this court and the petitioners can be given liberty to challenge the same before the 1st respondent by filing a revision. I make it clear that I have not considered the matter on merit and the 1st respondent

is free to pass appropriate orders in accordance with law, after giving an opportunity of hearing to the petitioners and other affected parties, if any.

Therefore, this Writ Petition is disposed of with the following directions:-

- i. The petitioners are free to challenge Exts.P1 and P7 before the 1st respondent by filing a revision within a period of ten days from the date of receipt of a certified copy of this judgment.
- ii. Once such a revision is received along with a certified copy of this judgment with a copy of this Writ Petition, the 1st respondent will consider the same and pass appropriate orders in it, after giving an opportunity of hearing to the petitioners and other affected parties, if any, within a period of two months from the date of receipt of a certified copy of this

judgment.

iii. The petitioners will produce a certified copy of this judgment along with a copy of this Writ Petition before the $1^{\rm st}$ respondent for compliance.

iv. All contentions raised in this Writ Petition are left open and the $1^{\rm st}$ respondent is free to pass appropriate orders in accordance with law.
