The petitioner in this transfer petition is the wife. She seeks transfer of O.P.No.1545/2019 pending before Family Court, Mavelikkara to Family Court, Thrissur, claiming that she is not in a position to contest the original petition by undertaking travel from her residence in Thrissur for a long distance to reach the Family Court, Mavelikkara.

2. The said original petition was filed by respondent/husband for dissolution of marriage. The contention of the petitioner is that she is residing in Poothole in Thrissur District and transfer of proceedings to Family Court, Thrissur is quite necessary to enable her to effectively contest the proceeding. The distance left behind between Family Court, Mavelikkara and her residence is stated to be 172 kms.

3. After hearing the submission made by the learned counsel appearing on both sides, I am satisfied that the request made by the petitioner is reasonable and the original petition is liable

to be allowed.

In the result, transfer petition is allowed ordering transfer of O.P.No.1545/2019 on the file of Family Court, Mavelikkara to Family Court, Thrissur. The transferee court on receipt of the records shall fix up an early date for appearance of parties and issue notice to them.

All pending interlocutory applications will stand closed.
