- 2. It appears from the affidavit filed on 17.6.2019 by the Registrar of the *Travancore Cochin Medical Council* that a decision was taken by the Legal Sub committee of the Council to unanimously withdraw the *offending circular No.C2-3420/2019/MC/F dated 27.4.2019* (Annexure-B) and also seek apology before the court, in the present Contempt proceeding. In pursuant to such decision, the communication dated 13.6.2019 [Ext.R1(b)] was issued by the Registrar, which is produced with the reply affidavit.
