THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 12.02.2024, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

The petitioners, who are stated to have completed B.Sc Medical Microbiology from the Mahatma Gandhi University and Calicut University, during the academic years 2014-2018 to 2016-2020, seek that the 3rd respondent – Kerala State Paramedical Council, be directed to grant them registration forthwith. They say that the denial of registration to them by the 3rd respondent is illegal and unlawful; and seek that they be directed to do so, within a time frame to be fixed by this Court.

2. The learned Government Pleader - Sri.P.S.Appu, in response to the afore submissions of Sri.Johnson Jose Panjikkaran - learned counsel for the petitioners, submitted that the 3rd respondent has been incapacitated from acceding to the request of the petitioners only because the course which they have completed, had been detached from the respective Universities, to be entrusted with the Kerala University of Health Sciences (KUHS). He, however, conceded that a Statement has been filed on behalf of the 2nd respondent, wherein, it has been averred in paragraph 3 thereof, that registration can be given to students who have successfully

completed their B.Sc Medical Biochemistry and B.Sc Medical Microbiology courses from Calicut, Mahatma Gandhi and Kannur Universities of Kerala for the period from 2014-2015 to 2018. He submitted that, this is because, all health related courses have only, thereafter, been affiliated with the 'KUHS'. He conceded that, therefore, those petitioners who have completed that course in such manner may be granted relief.

3. I notice from the pleadings that the Mahatma Gandhi University ad the Calicut University have filed separate counter wherein, they assert that affidavits, thev had admissions to various students, including the petitioners, up to the academic year 2016, because they were authorised to do so, being recognised under the Government norms, for such purpose. They assert that, therefore, the last of the batch, who passed out from their Universities, are of those students who were admitted in the year 2016, they having completed it in the year 2020. They thus contend that those students, who have completed the course in such manner, are also entitled to be registered by the 3rd respondent - Kerala State Paramedical Council, because the denial of the same, saying that the course had been entrusted to the 'KUHS', is factually incorrect.

- 4. Since the afore assertions of the Universities are without contest and since they affirm that they had affiliation to admit students up to the academic year 2016 - which they did as in the case of the petitioners - I am of the firm view that the 3rd respondent cannot refuse to grant them registration merely because the 'KUHS' has been constituted in the meanwhile. This is because, as long as the petitioners' admissions are not in question, and as long as they have completed the course meritoriously as has been conceded to by the Universities in their respective counter pleadings, they cannot be found to have not completed the course validly, particularly when the Universities assert - which is without contest - that they had authorisation and recognition to admit students and to complete the courses in question until the years 2016 and 2020 respectively.
- 5. The pleadings on record show that petitioners 1 and 2 belong to the 2014-2018 batch, who would, in any case, be entitled to relief even going by the counter affidavits of the 2nd respondent; while, petitioners 3 and 4 are of the 2015-2019 batch; with the 5th petitioner being of the 2016-2020 batch. For the reasons that I have already said above, their admissions to

various Universities cannot be found to be in error; and since it is admitted unequivocally that they have completed their course meritoriously, I have no doubt that they are also entitled to relief.

Resultantly, I allow this writ petition and direct the 3rd respondent to consider the application of the petitioners for registration, on its merits, *de hors* the objections referred above; which shall be done subject to all other requirements in law being satisfied, as expeditiously as is possible, but not later than one month from the date of receipt of a copy of this judgment.
