JUDGMENT

The petitioner is the legal heir of the original complainant in ST No.1402/2010 on the file of the Judicial First Class Magistrate Court-II (Mobile), Kottayam. The above case was initiated by the mother of the petitioner under Sec. 138 of the Negotiable Instruments Act. The trial court convicted the accused and sentenced to undergo imprisonment till rising of the court and to pay compensation of Rs. 1,01,117/- under Sec. 357(3) Cr.P.C. It was also ordered that in default of payment of compensation, the accused should undergo simple imprisonment for a further period of four months. An appeal was filed challenging the conviction and the sentence, but the same was confirmed by the Sessions Court, Kottayam as evident by Ext.P1. Pending the above appeal, the complainant died and therefore, the appellate court in Ext.P1 clearly stated that the accused shall pay an amount of compensation to PW2 Ambilimol, who is the petitioner herein. After Ext.P1 judgment, the accused Vijayakumari also died on 24.2.2018. The grievance of the petitioner is that the compensation is not recovered in accordance with Sec. 421 r/w 431 Cr.P.C. The petitioner filed an application before the Judicial First Class Magistrate Court-II, Kottayam in this regard as evident by Ext.P5. In Ext.P5, it is specifically pleaded that the deceased accused has got right in certain items of property. But, the learned Magistrate as per Ext.P6 order, dismissed the same stating that the petitioner has not proved the same. Hence, this Crl.M.C.

- 2. Heard the learned counsel for the petitioner and the learned Public Prosecutor. There is no appearance for the $\mathbf{1}^{\text{st}}$ respondent.
- 3. This Court perused Ext.P6 order. After going through the above order, I am of the considered opinion that the finding of the trial court to the effect that it is the duty of the petitioner

to prove that there is property to the deceased accused cannot be accepted. As per Sec. 421 r/w 431 Cr.P.C., it is the duty of the court to recover the amount as per law and pay the amount to the petitioner. If there is any dispute regarding the property, the court has got jurisdiction to get the report from the revenue authorities. Therefore, I am of the considered opinion that Ext.P6 will not stand. Hence, Ext.P6 can be set aside and the trial court can be directed to reconsider the matter accordance with law.

Therefore, this O.P.(Crl.) is allowed in the following manner:

- 1) Ext.P6 is set aside.
- 2) Judicial First Class Magistrate Court-II (Mobile), Kottayam will take appropriate steps under Secs. 421 r/w 431 Cr.P.C. to recover the compensation amount from any property in which the deceased accused has got right.
