THIS OP (FAMILY COURT) HAVING BEEN FINALLY HEARD ON 29.07.2022, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

# JUDGMENT

#### A. Muhamed Mustaque, J

This original petition is filed at the instance of the mother of the child. Paragraph 6 and 7 of the impugned order reads thus:

"After the said order granting interim custody to the father, the petitioner/mother has removed the child from the jurisdiction of this Court without informing the respondent and without seeking permission of the Court. In the event allowing the present application it will have the effect of approving the petitioner's unilateral decision to remove the child from jurisdiction of this Court. Moreover, shifting of the minor to Bangalore has resulted in making the previous interim order ineffective. The resultant consequences is that the minor as well as his father will not be able to have any frequent access as per the interim order granted by this Court.

Considering all these circumstances, I cannot find any sufficient reasons to approve the unilateral conduct of the petitioner. If the petitioner wants to remain at Bangalore she can very well hand over custody of the minor boy to the respondent/father till the final disposal of the OP."

- 2. Perhaps, chagrin by the conduct of the mother taking the child to Bangalore without permission of the Court, the Court passed such an order.
- 3. The mother was compelled to move to Bangalore because of her employment. The father is now stated to

be at Oman. The concern of the Court always should be with the welfare of the child, merely because, prior permission was not obtained from the Court for moving to Bangalore cannot itself result in passing an order of this nature. Since, the father is now not in India, we do not find any hardship is caused to the father on account of shifting of the child along with the mother to Bangalore. We, therefore, set aside the impugned order. We make it clear that for any arrangement to have contact or custody, the father is at liberty to move the Family Court, Thrissur well in advance before he comes down to India subject to educational convenience of the child.

4. A request has been made before us by the learned counsel for the father that his parents may be allowed to have interaction with the child. We also allow the father to have interaction through video call on every Friday and Sunday between 7 pm to 8 pm. The mother shall bring the child to Thrissur atleast once in a three months preferably on any Saturday and Sunday convenient to the mother to allow the child to be in the company with the grandparents. The grandparents are allowed to have the

custody of the child from on such Saturday at 11 am till the ensuing Sunday at 4 pm.

This original petition is disposed of setting aside the impugned order.
