JUDGMENT

The petitioners are presently working as empanelled conductors in the 2nd respondent corporation. In the year 2000, they were appointed as conductors through Though they were employment exchange. initially appointed on provisional basis, they were absorbed as empanelled conductors in the year 2005. The petitioners have completed almost 11 years and four months as on 21/12/2011 and are legally entitled to be regularized as per Ext.P1. According to the petitioners, the refusal to do so relying on a mere proposal submitted by the 2nd respondent before the 1st respondent is highly illegal.

2. The learned standing counsel for KSRTC submits that the corporation has taken decision to regularize the persons who have completed 10 years of service as per Ext.P1 order and therefore, the claims of the petitioners

shall be examined by the 2nd respondent corporation and necessary orders will be passed within two months from the date of receipt of a copy of this judgment.

3. It is found right that the petitioners have already completed 10 years of service in the KSRTC and therefore, their claim for regularization is allowed. Accordingly, I direct the 2nd respondent to consider the case of the petitioners individually and pass appropriate orders within two months from the date of receipt of a copy of this judgment.

This writ petition is closed as above.
