THIS WRIT PETITION (CIVIL) HAVING BEEN FINALLY HEARD ON 26.09.2019, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

The petitioner was initially appointed as a Part Time Sanskrit teacher. From 15.07.2007 onwards petitioner was promoted as a full time teacher. There were sufficient periods available to sanction full time post. However, this was not sanctioned due to ban.

- 2. Thereafter, on lifting the ban petitioner would claim for approval from 15.07.2007. Since, the manager had not executed bond in terms of G.O.(P)No.10/10/Gl Edn dated 12.01.2010, the approval was not granted. It is now submitted that the manager had also executed a bond.
 - 3. In Para 6 of the counter affidavit it is stated as follows:

"It is submitted that, the decision taken as per Exhibit P8 in the light of GO(P) 199/2011/GEdn dated 01.10.2011. The 5th respondent failed to execute a bond insisted as per GO(P)10/10/GEdn dated 12.01.2010. If such a bond was executed in time, the appointment ought to have been approved from the date of promotion ie, 15.07.2007. It is a fact that a full time post of HSA (sanskrit) was sanctioned with effect from 15.07.2007, even though the petitioner is a Rule 43 claimant as per Chapter XIV A KER,"

4. The approval for full time post was given only w.e.f 01.06.2011. In the light of fact that the manager had executed a bond, necessarily, approval shall be given to the petitioner w.e.f 15.07.2007. If the manager had not executed the bond, deeming that the manager had executed the bond, approval shall be given from the aforesaid date. Needful shall done for the approval within a period of two months. The monetary benefits consequent upon approval shall also be released within a further period of two months.

The Writ Petition is disposed as above.
