The petitioner is the Headmistress of Thirumala Devaswom Lower Primary School, Mattancherry. The writ petition was submitted by the petitioner seeking the following reliefs:

- "I. To issue a writ of Mandamus, or any other appropriate writ, direction or order directing the 2nd respondent to consider and pass appropriate orders on Ext.P3 representation of the petitioner, which is pending before the said authority, within a period fixed by this hon'ble court
- II. To grant any other reliefs as prayed for by the petitioner during the course of arguments, and which this hon'ble court deems fit to grant."

The grievance of the petitioner is regarding the non-consideration of her application for correcting the date of birth. According to the petitioner, she entered in service as UP School Teacher in the year 1992. Later, the petitioner submitted a representation before the Commissioner,

Government Examinations, Thiruvananthapuram correction for date of birth of the petitioner in S.S.L.C. by rectifying it as 04.09.1969. Acting upon the representation, Ext.P2 was issued to her, by which correction was carried out by showing the date of birth as 04.09.1969. On the basis of the same, the petitioner submitted Ext.P3 representation before the 2nd respondent seeking correction of date of birth in the service records of the petitioner. As there was inaction in considering the same, the petitioner approached this Court.

2. The learned Government Pleader opposed the prayer sought by the petitioner by pointing out that, the application submitted by the petitioner is beyond the time Government stipulated bν the G.O(P)as per No.45/91/P&ARD dated 30.12.1991. As per Government Order it has been stipulated that, the application for correction of date of birth has to be submitted by the

Government servant within a period of 5 years of his/her entry in service. In this case, the petitioner entered in service in the year 1992 and even the correction of date of birth in the S.S.L.C. certificate was in the year 2003. Therefore, it was pointed out that the same cannot be entertained.

3. After considering all the relevant aspects and hearing the learned Counsels appearing on both sides, I find force in the submission made by the learned Government Pleader in this regard. The Government Order dated 30.12.1991, specifically contemplates that, application for correction of date of birth has to be submitted within a period of five years from the date of entry in service. It is also specifically mentioned that the applications for condonation of delay and for entertainment of applications in relaxation of the conditions regarding the time limit shall be summarily rejected.

In this writ petition, there is no challenge against 4. said Government Order. Besides. the the learned Government Pleader also brought the attention of this Court to the judgment rendered by this Court in W.A. No.1829/2015, wherein a similar issue was considered and held that the application in such circumstances cannot be entertained. In the light of the proposition of law laid down by a Division Bench of this Court in W.A. No.1829/2015 and also in the light of the procedure and timeline contemplated in the Government Order dated 30.12.1991, I do not find any scope for considering the reliefs sought in this writ petition.

Accordingly, this writ petition is dismissed.
