JUDGMENT

This writ petition is filed by the petitioner seeking the following reliefs:-

- "(i) To issue a writ in the nature of certiorari or any other writ or order quashing Exhibit-P5 after calling for the records leading to the same;
- (ii) Issue a writ in the nature of mandamus or any other appropriate writ or order, directing the 1^{st} respondent to value and revalue the answer sheets of the petitioner;
- (iii) Issue a writ in the nature of mandamus or any other appropriate writ or order, directing the 1st respondent to revalue the answer sheets of all the candidates who appeared in the examination pursuant to Exhibit-P1 notification by High Court Judges;
- (iv) Complete the selection process to the post of District& Sessions Judges on the basis of the revaluation done as above."
- 2. The subject issue raised in this writ petition relates to selection to the post of District and Sessions Judge as per Ext. P1 notification dated 20.12.2012. Various contentions are raised with respect to the answers given by the petitioner to the questions and the illegal manner

in which the valuations were conducted and the petitioner has also sought for revaluation of the answer sheets.

3. The said issue with respect to whether a revaluation can be ordered in a writ petition was considered by a Division Bench of this Court in the judgment in Shinod K. v. the High Court of Kerala and Others in W. A. No. 383 of 2014 dated 10.06.2016 and held that revaluation cannot be done with regard to the very same selection process.

In that view of the matter, the issue raised by the petitioner in this writ petition is squarely covered by the said judgment. Therefore, this writ petition is dismissed in view of the legal proposition laid down by the Division Bench of this Court in the aforesaid judgment.
