# <u>J U D G M E N T</u>

The reliefs prayed for in this Writ Petition are as follows:-

- "i) To call for the records relating to Exhibits P1 to P2 and to issue a Writ of Certiorari or any other appropriate writ, direction or order quashing Ext P2 Possession Notice and further proceedings pursuant to it being illegal, improper, and issued without complying with the formalities as per the SARFAESI Act and Rules and which is against the Principles of Natural Justice.
- ii). To Issue a Writ of Mandamus or any other appropriate writ, direction or order directing the respondents to regularize the Loans considering the substantial amounts paid by the petitioner and allow the petitioner to pay the outstanding dues in reasonable installments and allow the petitioner to pay the regular monthly installments towards the loan along with it.
- iii) To Issue a Writ of Mandamus or any other appropriate writ, direction or order directing the respondents not to proceed pursuant to Ext P2 possession Notice and allow the petitioner to pay the due amounts in a reasonable monthly instalments.

- iv) Grant such other reliefs that may be deemed fit by this Hon'ble Court in due course of this case and to pass cost of this case. "
- 2. Heard both sides.
- 3. Upon instructions the learned counsel for the respondent Bank submitted that the total amount due to the bank is Rs.25,15,017/- as on 21/08/2023. The Bank is agreeable to permit the petitioner to remit the amount in 18 instalments.

In the above circumstances, the Writ Petition is disposed of with the following directions:-

- (i) The petitioner shall remit the total amount of Rs.25,15,017/- together with any accrued interest and charges in 18 equal monthly instalments.
- (ii) The first instalment shall be paid on or before 30.10.2023 and the subsequent instalments shall be paid on the last working day of every succeeding month.
- (iii) The respondent Bank shall accept the loan amount from the petitioner as stated above.

- (iv) In the event of default of payment of any one instalment, the respondent Bank is entitled to proceed in accordance with law.
- (v) The proceedings initiated under the SARFAESI Act against the petitioner shall be kept in abeyance to facilitate repayment as stated above.
