JUDGMENT

K.M. Joseph, J.

Petitioner has approached this Court seeking the following reliefs:

- "i) Issue a writ of mandamus or any other appropriate writ, order or direction, directing the first respondent not to harass the petitioner upon the complaint of third respondent.
- ii) Issue a writ of mandamus or any other appropriate writ, order or direction, directing the 1st respondent to take immediate action against the second respondent, considering Ex.P3 complaint forthwith."
- 2. Briefly put, the case of the petitioner, is as follows:

Petitioner has filed Ext.P1 complaint before the Judicial First Class Magistrate Court, Alappuzha against the third respondent. It is stated that the same was forwarded to the second respondent,

Sub Inspector of Police for investigation. The third respondent moved for anticipatory bail, which was dismissed vide Ext.P2 order. It is alleged that the civil police officer has demanded the petitioner to meet the second respondent for having a settlement of the dispute. Complaining of harassment by police, petitioner is before us.

3. Learned State Attorney would submit that there is no basis at all for the Petition. Petitioner apprehends that a complaint may be filed by the third respondent. Petitioner was called only once for recording his statement on his complaint. We record the said submission. We also record the submission of the learned State Attorney that no complaint as such has been filed by the third respondent, as things stand, and close the Writ Petition.
