This writ petition is filed by an Educational and Charitable Trust seeking the following reliefs:

- 1) To issue aw writ of mandamus directing respondents 1 to 4 to utilize its machineries to enforce the ban on politics inside the petitioner's campus.
- 2) To issue a writ of mandamus directing respondent No.1 to take action against erring Universities who have not complied with the directions to lay down rules and regulations binding all students to prohibit strike, gherao, dharna, bandh, hartal etc.
- **3)** To issue a writ of mandamus directing the 2nd respondent to lay down rules and regulations binding all students to prohibit strike, gherao, dharna, bandh, hartal etc.
- 4) To issue a writ of mandamus directing respondents 3 and 4 to utilize its machineries to enforce the ban on politics inside the petitioner's campus.
- 2. The paramount contention advanced in the writ petition is in respect of the campus politics and the violence occurring therefrom. On an analysis of the reliefs sought for, it is categoric and clear that they are of general nature. The learned counsel for the petitioner submitted that later it is known that the college in question was converted as a women's college. Since general reliefs are sought for, I

do not know whether anything survives to be considered at this juncture after a lapse of almost 7 years.

Therefore, the writ petition is disposed of with a direction to the authorities to look into the matter and consider the same, if anything survives to be considered, as is sought for by the petitioner.
