Heard the learned counsel for the petitioner and the learned Government Pleader.

2. No notice is required to be issued to respondents 3 and 4 in view of the order being passed in the writ petition.

3. The petitioner has come up with this writ petition seeking for police protection with regard to the peaceful survey of the petitioner's property, for which, notice has already been issued by the Taluk Surveyor. The Taluk Surveyor has issued notice for survey on 18.6.2015.

4. Learned counsel for the petitioner submits that the petitioner apprehends obstruction from the hands of the private respondents in the survey.

5. Under such circumstances, we are of the view that on a request made by the Taluk Surveyor, the 2nd respondent shall
