# J U D G M E N T

The petitioner is seeking for a direction to grant No-Objection Certificate (N.O.C.) for affiliation to the second respondent-Central Board of Secondary Education (C.B.S.E). The documents produced by the petitioner before the authorities concerned have been produced as Exts.P1 to P3 here.

2. It is averred in the writ petition that the application for N.O.C was rejected which was challenged before this Court and finally by Ext.P6 Judgment, a Division Bench of this Court issued appropriate directions in the matter. Similar matters were taken up before the Apex Court and, the Apex Court by Ext.P7 order has finally disposed of the Special Leave Petition, in the light of the new Government Policy dated 10/06/2011. The petitioner prays that in the light of the directions of the Apex Court, the application submitted by the petitioner may also be directed to be considered along with
