A housing loan availed of by the petitioners from the 1st respondent Bank is in default. As a result, SARFAESI proceedings were initiated and finally Ext.P2 possession notice was issued. It was at that stage this writ petition has been filed with a prayer that the petitioners be allowed to clear the defaulted dues and also for a direction to get the loans regularised. In this writ petition, this Court by order dated 26/9/12 granted stay of further proceedings pursuant to Ext.P2 possession notice and Ext.P4 notice issued by the Advocate commissioner subject to the petitioners remitting ₹1,00,000/- and according to the counsel, this order has been complied with.

2. Although notice has been issued and has been served on the respondents, there is no appearance on their behalf. In such circumstances and also taking note of the fact that the petitioners have already complied with the interim order passed by this Court, I dispose of this writ petition with the following directions:-

- (1) That ₹1,00,000/- paid by the petitioners shall be adjusted towards the defaulted instalments due from them.
- (2) That the balance amount due towards the defaulted instalments shall be paid by the petitioner within one month from today.
- (3) Subject to such payment, coercive action will be deferred and if payments are made as above, the loan in question will also be regularised and the petitioners will be permitted to pay the balance liability in terms of the loan agreement with the Bank.
- (4) Petitioners will produce a copy of this judgment along with a copy of the writ petition before the 1st respondent for compliance.
